### Registration Terms and Conditions

- Full payment for registration fees must be received prior to the Event
- Prices are listed in USD or AUD (attendee can choose which currency to pay in) and exclude tax
- If you cancel your registration on or prior to 02 March 2021 you will receive a refund less a cancellation fee of USD\$25 or AUD\$33.
- Cancellations made after 02 March 2021 are non-refundable.
- The Privacy Act 1988 provides that, before your name and contact details can be published in a list of participants you must give your consent. If you select 'Yes, I do want my details to be included in the list of participants' on the registration form or by email, your details may be distributed to:
