Registration Terms and Conditions

- Full payment for registration fees must be received prior to the Conference.
- All prices are in Australian dollars and include Goods and Services Tax of 10%.
- If you cancel your registration on or prior to 16 October 2020 you will receive a refund less a cancellation fee of AU\$50. Cancellations made after 16 October 2020 are non-refundable.
- The Privacy Act 1988 provides that, before your name and contact details can be published in a list of participants you must give your consent. If you select 'Yes, I do want my details to be included in the list of participants' on the registration form or by email, your details may be distributed to:
