Registration Terms and Conditions

- Full payment for registration fees must be received prior to the Meeting.
- All prices are in New Zealand dollars and include Goods and Services Tax of 15%.
- If you cancel your registration on or prior to 15th June 2022 you will receive a refund less a cancellation fee of \$100. Cancellations made after 15th June 2022 are non-refundable.
