	The award will cover the recipient's expenses (return economy airfare to Japan, registration, accommodation, living expenses) to attend and present at the Annual Scientific Meeting of the Japanese Respiratory Society in the following year.				
Eligibility Criteria	To be eligible for the award, the applicant must:				
	 Be a current member of the TSANZ¹, A citizen or permanent resident of Australia or New Zealand, 				
	 Have completed advanced training in any health or science discipline within the last five years of the closing date for this application, or 				
	Have completed a research higher degree in an area directly relevant to respiratory research within the last five years of the closing date for this application.				
	 Be submitting an abstract for an oral presentation as a presenting author for the TSANZ ASM, and 				
	4. Be available to attend the JRS ASM to be held in the following year to make an oral presentation on their work or in their area of expertise.				
	Previous recipients of this award over the last three years are not eligible to apply.				
Condition	The following conditions must be meet by members receiving this award:				
	The award must be used within one year of the TSANZ ASM.				
	 Recipients are required to submit a report within 2 months of attendance at JRS, for publication in the TSANZ newsletter. 				
	Note: These conditions must be met to remain eligible for future award rounds.				
Applications	Applicants must submit only an electronic application as a single PDF file via the online abstract portal or email to <u>tsanzsrs@tcc.co.nz</u>				
	Your application should include:				
	 A track record (maximum two A4 pages). Include any significant career disruptions supporting eligibility outside the listed criteria. 				
	 Publications over the last five years, excluding career disruptions (unlimited pages). 				
	 All text must be submitted on A4 pages with a 2cm margin to the top, bottom, left and right. Text must be single line spaced, with size 12 Times New Roman font. No columns are permitted.
