**Registration Terms and Conditions**

- Full payment for registration fees must be received prior to the Meeting.
- Prices for ASM registration are in Australian dollars and include Goods and Services Tax of 10%.
- Prices for the NZ Hub attendance and Lung Cancer Screening Symposium are in Australian dollars and include NZ Goods and Services Tax of 15%. A New Zealand Tax invoice is available upon request.
- If you cancel your ASM registration on or prior to 01 April 2021 you will receive a refund less a cancellation fee of AU\$50.00. Cancellations made after 01 April 2021 are non-refundable.
- If you cancel your NZ Hub or Lung Cancer Screening Symposium attendance on or prior to 01 April 2021 you will receive a refund less a cancellation fee of AU\$30.00. Cancellations made after 01 April 2021 are non-refundable.
