Registration Terms and Conditions

- Full payment for registration fees must be received prior to the Meeting.
- Prices for ASM registration are in Australian dollars.
- Prices include Goods and Services Tax of 10% for those who indicated in the online form that they reside in Australia.
- Prices do **not** include Goods and Services Tax for those who indicated in the online form that they do **not** reside in Australia.
- If you cancel your ASM registration on or prior to 01 March 2022 you will receive a refund less a cancellation fee of AU\$50.00 (GST inclusive, if applicable). Cancellations made after 01 March 2022 are non-refundable.
