Registration Terms and Conditions

- Full payment for registration fees must be received prior to the Summit.
- All prices are in New Zealand dollars and include Goods and Services Tax of 15%.
- If you cancel your registration on or prior to 18 September 2021 you will receive a refund less a cancellation fee of \$28.00 (including GST). Cancellations made after 18 September are non-refundable. Please note this means the Student Registration rate is non-refundable at any cancellation time due to the subsidised rate offered and the minimum administration fee per participant.
- The Privacy Act 2020 provides that you are aware the registration form is collecting your details on behalf of the event hosts, WISPA and Sport NZ. All registration information will be accessible by these organisations for the purposes of managing this event and post-event follow up. If you have indicated attendance at a regional event your details will also be shared with the local organising committee. All data collection adheres to the Sport NZ [Privacy Policy](#)
- If, for reasons beyond the control of the Organising Committee, the Summit is cancelled, registration fees will be refunded after the deduction of expenses already incurred.
